Team Rosters will be emailed to each club. Coaches, please double check your team rosters for the correct spelling of your athlete's names, correct date of birth & missing USAG numbers.

Clubs —please email Sharyn Strickland at Sharyn@usacompetitions.com with the names and USAG numbers of all coaches that will be attending the New Year's Invitational. All USAG Professional Memberships will be verified prior to the event.

Athlete & Coach Registration – All athletes and coaches will register at the South Registration Desk, across the hall from the competition venue, Veracruz Exhibit Hall A. At that time, you will submit a *Disney Sports Waiver and Permission Form* (see below), and receive credentials prior to entering the competition arena. ****Athletes and coaches must submit waivers individually at registration to receive meet credentials.*** Coaches must wear credentials at all times, and athletes must carry credentials with them. Credentials will be your “ticket” to enter the facility throughout the weekend. Athletes will receive a gift at registration prior to competition. Please make sure to allow time for the walk to the Veracruz Exhibit Hall A. Gymnasts (and coaches) should arrive at least 20 minutes prior to scheduled general stretch to allow time for the registration process. ***All participants are welcome to pre-register on Thursday, Dec. 30th between 3:30pm and 6:30pm at the South Registration Desk.***

Disney Sports Waiver and Permission Form—Disney requires all participants (athletes & coaches) to submit this document prior to entry. Please copy the enclosed form as needed. Bringing pre-filled out forms will expedite on site registration. There will also be forms available at the registration table. Coaches, do not hand in a stack of pre-filled waivers for your team. Waivers must be submitted individually to receive Disney credentials.

Thursday on-site workouts—There will be a workout offered at the Coronado Springs venue on Thursday beginning at 4:30pm. Advanced notice that you will attend (along with # of athletes working out) is required so that we may organize you into groups, for an efficient workout session. ***Please email Sharyn Strickland between now and Dec.23rd to sign your athletes up for the workout .*** Athletes and coaches attending Thursday workouts must register prior to entering the venue. ***All participants are welcome to pre-register on Thursday as well.***

On my own and/or my child or ward's behalf, and on behalf of my and/or my child or ward's heirs, executors, administrators and next of kin, I hereby release, covenant not to sue, and forever discharge the Released Parties (as defined below) of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my or my child or ward's participation in the Event and/or any such activities, and further agree to indemnify and hold each of the Released Parties harmless from and against any and all such liabilities, claims, actions, damages, costs or expenses including, but not limited to, all attorneys' fees and disbursements up through and including any appeal. I understand that this release and indemnity includes any claims based on the negligence, action or inaction of any of the Released Parties and covers bodily injury (including death), property damage, and loss by theft or otherwise, whether suffered by me or my child or ward either before, during or after such participation. I declare that I and (if participating) my child or ward are physically fit and have the skill level required to participate in the Event and/or any such activities. I further authorize medical treatment for me and/or my child or ward, at my cost, if the need arises. For the purposes hereof, the "Released Parties" are Walt Disney World Hospitality & Recreation Corporation, Walt Disney World Co. and Disney Destinations, LLC, and their respective parent, subsidiary and other affiliated or related companies; the Event Host referenced above, all Event sponsors or charities, and each of their respective parent, subsidiary and other affiliated or related companies; Reedy Creek Improvement District and its Board of Supervisors; and the officers, directors, employees, agents, representatives, successors, assigns and volunteers of each of the foregoing entities.

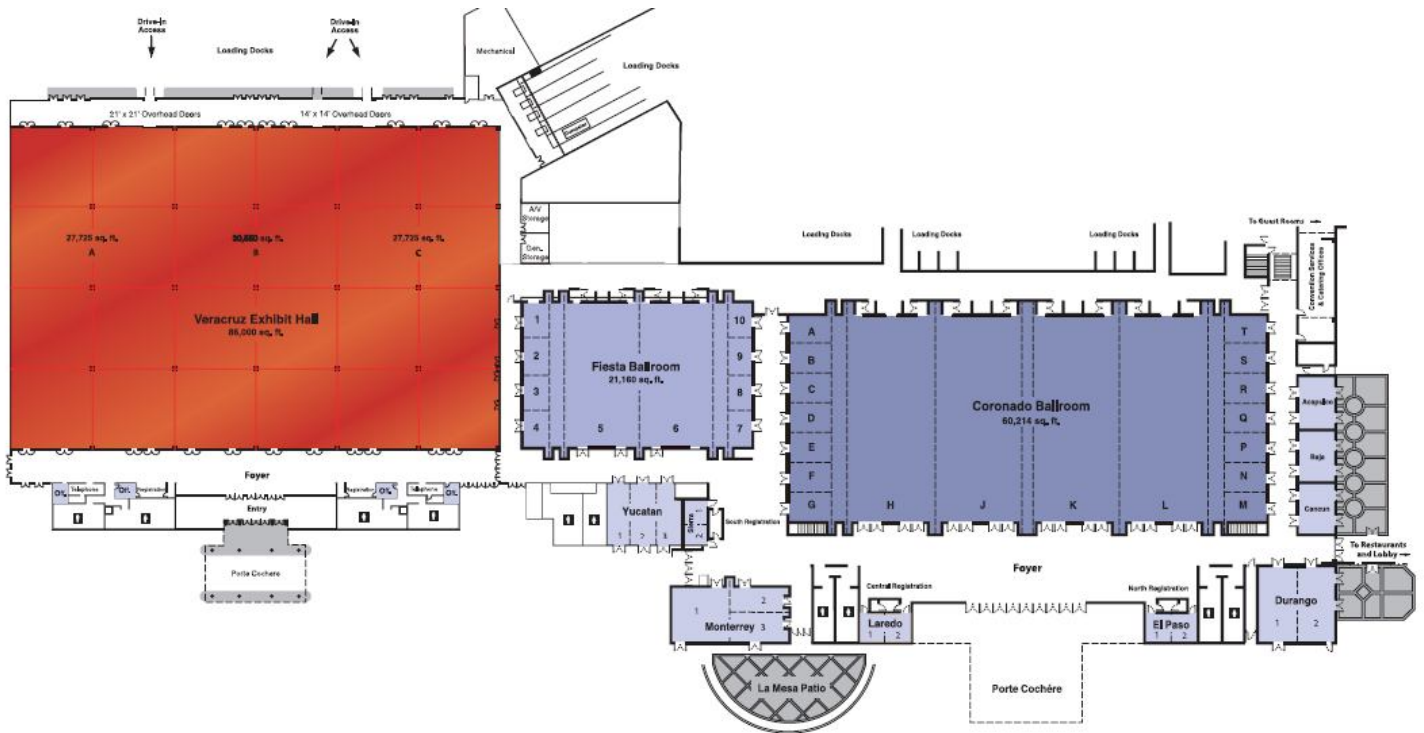
